

We Care Foundation has worked with Moon Mountain as a community partner for the past five years as we work together to meet the needs of our families. Chuck Nolan is the coordinator of this organization and has done a stellar job of helping to support our students. They have helped our needy families during the holiday seasons, both at Thanksgiving and the Winter Holidays, as well as supporting the needs of students throughout the year.

2. Please give specific examples of ways in which the nominee shows excellence in performance of his or her job duties.

Chuck does a great job of checking in with our school health technician to identify any needs among our families or student needs that might be supported by this organization. They are willing to help with school supplies, have assisted us with additional back packs for children who cannot afford them and supplied toys during the holiday season for those children in need. At the Head Start celebration this year they not only supplied toys for each of the children in the program, but circulated in the audience in the cafeteria to ensure that every child (even toddlers) who had come to see their siblings perform received a teddy bear.

3. If the nominee is a volunteer or community member, please provide information on the variety of ways the nominee volunteers meaningful time and expertise to the school and/or the WESD.

Nothing is ever too much trouble for this group and recently one of our families experienced a fire in their apartment. Chuck has worked to get this family supplied with household items, clothes and is even working with an agency to help them relocate. This kind of assistance for those who have experienced the trauma of losing their home is so vital to providing a sense of security and comfort to children so that they can continue on their pathway of learning.

4. Please provide examples of ways the nominee actively and creatively seeks to improve public education.

While this foundation does not provide services directly related to the classroom learning, the support they offer to families helps to relieve the stress of not having enough money to provide for their children. What research tells us is that when children have their basic needs met—food,

clothing and shelter- they will be ready to learn and have a better chance at being successful at school. The We Care Foundation offers our school that kind of support.

5. Please provide specific examples of the ways the nominee is a positive role model of customer service for students, staff and community.

We Care Foundation through the help of Chuck Nolan certainly is a great example of a positive role model and customer service like none other. Chuck is always willing to help in any way he can within the guidelines of the organization.

Our District's Mission and Vision statements certainly align with the focus of this organization that helps to make sure both children and families can achieve.

Since the beginning of our work together, this organization has worked closely to improve and enhance the service they provide to our community. At any time when there is a need, they work with us to meet that need, or refer us to anyone else that could help to solve the concern. Chuck, as the representatives of We Care Foundation, certainly represent a positive focus on helping our community. This partnership has been strong for over five years and this organization is choosing to do community service through a school that is also the hub of the community and we both believe that if families are supported, have food and clothing, then children come to school ready to learn and families feel supported by their school. This organization has also broadened their service to not only Moon Mountain, but responded recently to a need in the Acacia school community where they are helping a family who suffered the loss of their home due to a fire. Again, this organization is responding to needs of families and children. This kind of support is vital to a true professional learning community as it relates to both strong community partnerships and strong parent involvement.
